The Ketchikan Gateway Borough Code of Ordinances imposes a tax on all vessels in excess of 12 feet in length. The applicable code section follows:

Section 45.11.025(b)(1) states: "Classifies boats and vessels twelve (12) feet or more in overall length for the purposes of taxation and establishes the assessed valuation of such boats and vessels on the basis of their registered or certified net tonnage. The tax on boats twelve (12) feet or more in overall length shall be: a. Twenty-five dollars (\$25.00) a year for a boat or vessel of five (5) net tons or less, b. Seventy-five dollars (\$75.00) a year for a boat or vessel of more than five (5) net tons."There are no exemptions for boat tax other than governmental agencies.
