KETCHIKAN GATEWAY BOROUGH BY-FAX BALLOT APPLICATION

GENERAL INFORMATION

1. Municipal elections are held annually the first Tuesday of October to elect members of the Assembly and School Board. The mayor is elected every three years. Special elections are held when called by the Assembly or if there is a successful referendum or initiative process by the qualified voters of the Borough.
2. You must apply **separately for each election** for an electronic ballot.

INSTRUCTIONS

The Electronic Absentee Ballot Application must be received not less than the day immediately preceding the election.

Complete ALL information requested. The application may be completed on line and printed out. You **MUST** provide your residence address in the Ketchikan Gateway Borough. Use the description of the physical location--street number, milepost, trailer court and space number, etc.

SIGN your application. This is a requirement of law. [Another individual may apply for an absentee ballot on behalf of a qualified voter if that individual is designated to act on behalf of the voter in a written general power of attorney or a written special power of attorney that authorizes the other individual to apply for an absentee ballot on behalf of the voter. A copy of the power of attorney must accompany the absentee ballot application.]
