This brief responds to media questions and provides an update on information from the Emergency Operations Center (EOC) and its partner agencies.

COVID-19 Case Count Update

The number of positive cases of COVID-19 in Ketchikan is fourteen (14). Of these cases, two (2) individuals had a recent history of travel, and eleven (11) individuals were identified as having been in close contact with an individual diagnosed with COVID-19.

Ketchikan COVID-19 Case Recovery Information
10 out of 14 have recovered and are no longer being monitored by Public Health.
Criteria for release from monitoring/quarantine:
* At least 3 days (72 hours) have passed since recovery defined as resolution of fever without the use of fever-reducing medications and improvement in respiratory symptoms (e.g., cough, shortness of breath); and,
* At least 7 days have passed since symptoms first appeared.

137 tests have been conducted for COVID-19 in Ketchikan, with the following results:

Compliance to Social Distancing Directives

We have received questions regarding consequences to members of the public who fail to follow the social distancing mandates and directives that have been put into place by the President of the United States, Governor of the State of Alaska, and the local Ketchikan Gateway Borough, City of Ketchikan, and City of Saxman authorities.

While the State of Alaska does have the ability to enforce violations of any of the mandates issued, the State and local governments are fully expecting compliance from our citizens. It is our hope that citizens will respect the directives for social distancing for the health and well-being of all and to #flattenthecurve and #stopthespread.

If there are violations of mandates and social distancing directives, the greatest penalty would be a widespread outbreak of COVID-19 to an extent that our local healthcare providers could not accommodate. Again, we are hopeful that are citizens will comply with the mandates for social distancing so that does not occur. It is our hope that law

enforcement officers will not have to issue citations to citizens for failing to follow directives. If they do have to do so, it would be in line with reckless endangerment statutes.

Ketchikan International Airport Travel Updates

Due to the rapid spread of COVID-19 and the high incidence of travel-related infection, the State of Alaska has instituted a mandatory 14-day quarantine for all passengers arriving from out of state. In accordance with the State mandate, accommodations have been made at the airport for travel declaration forms to be provided. 30 Days to Slow the Spread – Excerpts from the White House Guideline

- Listen to and follow the directions of your STATE AND LOCAL AUTHORITIES.
- IF YOU FEEL SICK, stay home. Do not go to work. Contact your medical provider.
- IF YOUR CHILDREN ARE SICK, keep them at home.
- IF SOMEONE IN YOUR HOUSEHOLD HAS TESTED POSITIVE for the coronavirus, keep the entire household at home. Do not go to work. Contact your medical provider.

- IF YOU ARE AN OLDER PERSON, stay home and away from other people.
- IF YOU ARE A PERSON WITH A SERIOUS UNDERLYING HEALTH CONDITION that can put you at increased risk (for example, a condition that impairs your lung or heart function or weakens your immune system), stay home and away from other people.
